ACE008.e - To consider re-incising/re-enamelling the names on the War Memorial

1. Background

The War Memorial at Holy Trinity Church was professionally cleaned on 4 May 2020. CPC obtained a small grant from War Memorial Trust (WMT). At the time of applying for the grant original images were sent and WMT considered the lettering was still legible as mentioned in their response hereunder.

Quote:

Having reviewed the additional photographs submitted with the full Application Form it is not felt that there is sufficient evidence to justify the re-cutting and re-painting of the inscriptions because the inscriptions are legible. Lettering can only be re-cut a finite number of times and such work should only be undertaken when absolutely necessary and as a last resort. In addition, it is often the case that following cleaning the legibility of names and inscriptions improves considerably so re-cutting is not required. Based on our experience we would recommend a project to clean the war memorial now. After cleaning the legibility of the lettering could be reassessed and if necessary further works could be undertaken. 2. Findings

After the clean it would appear the lettering is still difficult to read as can be seen from the images below.





3. Costs

At the time of obtaining initial cleaning quotations, the following estimates were received in respect of the inscriptions. All contractors reserved to review the inscriptions after the monument was cleaned.
