Summary of the Council's Environmental Health enforcement policy

It is our policy that enforcement action is based upon an assessment of the probability of harm to health, safety, quality of life, and non-compliance with the law. We recognise that proportionality, consistency, transparency and targeting are vital elements of this policy. We therefore seek to ensure that our enforcement actions are:

- **Proportionate** and thus action taken to achieve compliance with the law will be proportionate to the seriousness of the breach.
- Consistent so that a similar approach will be taken in similar circumstances to achieve similar ends.
- **Transparent** in that when enforcement action is taken, an explanation will be given of the legal basis for the action and our procedure.
- **Targeted** on those whose activities give rise to the risks that are most serious or the risks which are least well controlled.

Enforcement decisions will be consistent, balanced, and fair and relate to common standards. When taking action, consideration will be given to:

- The seriousness of the offence.
- The history of the business or individual concerned.
- Confidence in management and / or the attitude of the individual concerned.
- Consequences of non-compliance.
- The likely effectiveness of the various enforcement options.

FOOD HYGIENE RATING SCHEME

Food Hygiene Rating

Your food hygiene rating will be published at ratings.food.gov.uk if no appeal is lodged within 21 days of the notification of your rating. You may request in writing that your rating is published before the appeal periods ends. If you appeal, your food hygiene rating will be shown as 'awaiting publication'. When stickers are issued, they remain the property of Mid Sussex District Council and all rights are reserved. Only one rating – the most recent – must be displayed at any point in time. If a sticker is used to mislead the public or misrepresent the food business in any way including by defacing and tampering this may constitute an offence under trading standards legislation for example an offence under the Consumer Protection from Unfair Trading Regulations 2008, which impose a general prohibition on unfair commercial practices.

Right to Appeal the Food Hygiene Rating

- As the food business operator of the establishment you have a right to appeal the food hygiene rating given following your inspection if you do not agree that the rating reflects the hygiene standards and management controls found at the time of the inspection.
- The food business operator has 21 days (including weekends and bank holidays) from the date of receipt of this notification to lodge an appeal.
- In the first instance, the food business operator should discuss the matter with the inspecting officer to
 resolve any dispute about the food hygiene rating in an informal manner. The officer should be able to further
 clarify and explain how it was derived.
- If the dispute is not resolved informally, you should complete a Food Hygiene Rating Scheme Appeal form and return it to the Licensing, Food and Safety Team Leader. Contact details are provided on page 3 of this report.
- The Licensing, Food and Safety Team Leader will review your rating and communicate the outcome of your appeal to you within 21 days.

Food Hygiene Rating Scheme 'Right to reply'

- As the food business operator of the establishment you have a 'right to reply' in respect of the food hygiene rating given following your inspection.
- The purpose is to enable you to give an explanation of subsequent actions that have been taken to make the required improvements as detailed in the inspection letter, or to explain mitigation for the circumstances at the time of the inspection. It is not for making complaints or for criticising the scheme or the officer who carried out the inspection.
- If you wish to use this 'right to reply', please complete a Right to Reply form and return it to the Licensing, Food & Safety Team Leader contact details are provided on page 3 of this report.
- Your comments will be reviewed and may be edited in order to remove offensive or defamatory remarks before being published online and displayed together with your food hygiene rating at <u>Search for ratings |</u> Food Standards Agency.
- There will be a statement at <u>Search for ratings | Food Standards Agency</u> that will highlight that the accuracy of your comments has not been verified by local authority officers.

Food Hygiene Rating Scheme Request for a Re-Visit

- As the food business operator of the establishment you have a right to request a re-visit for the purposes of re-rating if you have taken action to rectify the non-compliances identified at the time of inspection.
- There is a charge for this re-visit. There is no limit on the number of requests you may make, but the charge will be applicable each time. Applications will only be accepted and deemed valid once payment has fully cleared.
- You must provide details of the improvements made with your request, including supporting evidence where appropriate.
- The re-visit will be carried out within a maximum of three months following the receipt of your request and payment of the fee.
- The Food Safety Officer will give you a 'new' food hygiene rating based on the level of compliance that is found at the time of the re-visit you should be aware that your rating could go up, down or remain the same.
