Hi Sam,

MSDC is holding Public Art s106 contributions for a number of towns and parishes so I was considering pooling resources to commission a District wide project.

The suggested theme is around public rights of way/travel and the aim is to encourage people to get out and about, promote walking and cycling, participate in arts activities and to provide information about the local area.

We could commission an artist to produce a series of way-markers (other parishes have suggested murals and pictorial maps) and link them digitally with QR codes that take visitors to some creative content (music, stories, images) produced by local participants. Parishes could identify specific sites, local themes and participant groups for their area.

We have £7,615 for Public Art in Cuckfield so if you would like more information or want to be involved please let me know asap.
