1.0 PRELIMINARIES

- 1.1 The Employer is Cuckfield Parish Council, Queen's Hall, High Street, Cuckfield, West Sussex RH17 5LN, Telephone: 01444 451610 Email: clerk@cuckfield.gov.uk
- 1.2 The Employer will enter into a contract with the successful tenderer, hereafter called the Contractor, to carry out sundry paving works to Cuckfield Cemetery, in the environs of Holy Trinity Anglican Church.
- 1.3 The tender will be based on the attached plan and the specifications and areas shown in this tender document.
- 1.4 The Contractor will have access to the area marked on the plan for his secure compound for the duration of the works. He must leave it tidy and free of all materials and rubbish upon completion.
- 1.5 The Contractor will be entitled to interim payments fortnightly. Each payment will have a 10% retention until the penultimate payment when 5% will be withheld for six (6) months to ensure the works have settled in well. The final payment will be made upon an inspection to ensure there are no defects, whereupon the retention will be released or deferred until rectification of the defects.
- 1.6 The Contractor must be aware that this is a working cemetery and will remain in full operation at all times for funerals, visitors and regular church services. Notice will be given for burials and the Contractor must provide access or an alternative route for funeral directors, sexton and mourners. Pedestrian visitors must be allowed access to individual graves.

2.0 SPECIFICATIONS

2.1 Clay multi coloured pavers shall be xxx brick or similar and laid on 100mm sharp sand bed in accordance with the manufacturer's instructions with a single brick layer to edges bedded and haunched with cement and sand 1:4 and laid on excavated surfaces, finished with kiln dried sand brushed into joints.
