# 2d Research objectives: A survey of the community of Cuckfield will take place: To identify roads which would benefit from a reduction in speed limit to 20mph. To identify roads where a reduction in speed limit may reduce the occurrence of road traffic accidents. To identify other traffic calming mechanisms that may be supported by the community either separately or alongside speed limit reductions. To improve community engagement and participation in Cuckfield Parish Council decisions. To submit a proposal to West Sussex County Council for traffic calming improvements with demonstrable support of the community. 2e Research methods: Please provide details of both quantitative and qualitative research methods to be used by answering these questions. What are your two specific research tools? Delete as appropriate: 1. Survey (quantitative) and Focus Groups (qualitative) 2. For each method, who will your sample include and why? I will include the following in the survey sample: Cuckfield Parish Councillors - they are aware of the traffic issues within the village and also have an awareness of the feelings of residents through their role as Councillors. Local Speed Watch - they regularly monitor traffic speeds within the village and can identify particular areas worthy of focus based on speeding statistics. Residents – those who have previously contacted the Parish Council with concerns and feedback regarding traffic calming within the village. Local shopkeepers - invited to complete the questionnaire due to their location on the High Street in Cuckfield and this being one of the target areas for speed reduction. Residents – anyone with an interest in the traffic issues within Cuckfield who wishes to be partake. I will include the following in the focus group sample: This will be a question on the survey, so participants will be selected from those who respond with an interest in taking part. 3. How will they be selected and recruited? The survey will be publicised via the Parish Council website and Facebook page, and posters will be put up within the local area. An article will be placed in the local newsletter with a link to the online survey. 4. Where and how will you collect the data for each method? A traffic calming survey will be created online and shared via Cuckfield Parish Council's website, social media and direct invitation where contact details are known (as per GDPR rules). Attendance at the local monthly market which runs on the second Saturday of the month from 9am -12pm, based within the centre of the village (Rose & Crown car park), to ask people to complete the questionnaire face to face (a paper copy of the survey will also be available), and take additional details if they would be willing to be considered for attendance at the focus group session(s). Paper copies will be made available at the Queen's Hall. 5. Do you need written permission from an organisation before you start your research

(eg school, work premises, law courts) using each tool and why or why not? Cuckfield Parish Council will resolve to give permission for this research to be completed at the next Roads & Traffic Committee meeting on Thursday 20th April 2023.

6. Is there any risk to yourself in either case (*eg lone working with a respondent*)? If so, how will you protect yourself?

The risk is minimal as all research will take place during the day in public locations. The Chairman of the Roads & Traffic Committee can be invited to attend the monthly market questionnaire alongside myself to reduce the lone working risk, likewise the focus group sessions will be held in the public building owned by the Parish Council (the Queen's Hall) and can also have the Chairman attend as co-host. CCTV is available within the Queen's Hall.

7. Is your research funded by a third party, including your employer? If so, please give details.

Research will take place during the working day where possible, and funded as my role as Clerk as this research will be used by Cuckfield Parish Council to progress their traffic calming aims.

#### What is the research about?

This research is exploring traffic issues experienced within Cuckfield, with a view to identifying improvements that can be made to prioritise the experiences of vulnerable road users (VRUs). VRUs are pedestrians, cyclists and equestrians and they exist in both urban and rural settings.

This study contributes towards the Level 5 Community Governance studies of Sam Heynes, the Parish Clerk for Cuckfield. The joint aim is to provide evidence which can be used to present to West Sussex County Council Highways department in pursuit of traffic calming measures within specific areas of Cuckfield identified within this study.

### What does the study/participation involve?

Completion of a simple questionnaire will should take no longer than 10 minutes to complete.

A one hour focus group session to explore in more detail the findings of the questionnaire, exploring the pros and cons of pursuing traffic calming or speed reductions for the specific roads identified.

All participants should come prepared to contribute to the traffic calming debate, with

their own experiences as either a driver, resident, business owner, cyclist or pedestrian within Cuckfield.

The focus group meetings will take place at the Queen's Hall, High Street, Cuckfield, RH17 5EL, at a date and time to be arranged.

Participation within this study is voluntary and you may withdraw at any time. No comments will be attributed in the research findings

All questionnaire data will be collated anonymously; those participants who are willing to take part in a focus group should include their contact details for this purpose only.

All focus group data will also be collated anonymously. All data collected anonymously will remain part of the study, even should an individual request to withdraw from the study, as it will not be possible to identify their data due to the anonymity of collection. Personal data will not be used for any purpose outside of this study.

Findings and conclusions made throughout the course of this study will be shared with Cuckfield Parish Council and West Sussex County Council as part of the evidence gathering required to pursue implementation of the proposed traffic calming changes.

This data will also be shared with the Community Research Module Leaders of De Montfort University.

A separate Consent Form will be available separately.

#### Who is doing the research?

Sam Heynes, Cuckfield Parish Clerk, will be leading this research, as part of studying Level 5 Community Governance at De Montfort University, Leicester.

If you have any concerns about this research, for any reason and at any time, you may contact my supervisor James Derounian. His contact details are provided at the end of this information sheet.

#### Who is funding the research?

Cuckfield Parish Council is funding this research.

#### Why have I been chosen?

Questionnaires will be shared for any interested Cuckfield resident/business owner to complete.

Subject to expressing an interest in participating further on the questionnaire, you may be invited to join a focus group to share further thoughts and experiences of traffic issues within Cuckfield.

Up to 4 focus groups with between 6-10 participants will be run on dates to be agreed.

#### Do I have to take part?

It is up to you to decide whether or not to take part. If you do decide to take part you will be given this information sheet to keep and be asked to sign a consent form. If you decide to take part you are still free to withdraw at any time and without giving a reason.

#### What if I agree to take part and then change my mind?

You can withdraw from the study at any time, without giving a reason.

Any data collected up to the time of withdrawal will remain part of the study as all data will be collated anonymously, making it impossible to identify and remove the data.

#### What happens to the information I provide?

- b) The research data will also be used by Cuckfield Parish Council to inform evidence for submission to West Sussex County Council in order to pursue implementation of traffic calming schemes within Cuckfield.

#### Will my taking part in this study be kept confidential?

All information which is collected about you during the course of the research will be kept on a password protected database and is strictly confidential. You will be given an ID code which will be used instead of your name. Any identifiable information you may give will be removed and anonymised.

Raw data is normally kept for 5 years after a study has been completed as per DMU policy. However this data will be destroyed once completed of a traffic calming proposal has been submitted to WSCC for consideration.

The Community Research supervisor will also have access to the data and members of the faculty human research ethics committee may require access to check that the study has been conducted in accordance with the approval.

You should also be aware that I may be duty bound to pass on information that you provide that reveals harm has occurred to a child or other vulnerable individual.

Confidentiality during focus group interviews cannot be guaranteed as that duty cannot be imposed on all participants in this kind of interview.

#### Will anyone know that I am taking part?

Completion of the questionnaire and the data shared will remain confidential. Fellow focus group members will be aware of your identity and involvement in the study. If you tell me that harm has occurred to a child or other vulnerable individual, or provide evidence that laws have been broken, I have a duty to pass that information onto the appropriate agency. Only in those circumstances would I have to reveal your identity.

#### What will happen to the results of the research study?

Findings will be used in a presentation to the Community Research Module Leaders at DMU in order to assess the assignment being completed.

Findings may also be used in a report to WSCC in order to progress a request to make traffic calming changes for the benefit of the community of Cuckfield.

#### What are the possible advantages and disadvantages of taking part?

The advantage of taking part is that you will have a say in the potential future traffic calming priorities identified for Cuckfield.

One of the disadvantages of participation is as giving up your time to take part, also that your traffic calming priorities may not be taken forwards for further consideration.

#### What are the possible benefits of taking part?

The possible benefit of taking part is that the traffic calming priorities raised may be taken forwards to West Sussex County Council for consideration with a view to changes being made for the wider benefit of residents of the village.

#### What if something goes wrong?

If you are harmed by taking part in this research project, there are no special compensation arrangements. If you are harmed due to someone's negligence, then you may have grounds for a legal action but you may have to pay for it. Regardless of this, if you wish to complain, or have any concerns about any aspect of the way you have been approached or treated during the course of this study, the normal University complaints mechanisms should be available to you.

#### Who can I complain to?

If you have a complaint regarding anything to do with this study, you can initially approach the lead investigator.
