ACE012 To receive apologies for absence

ACE016 Assets

The Chairman agreed to bring forward Item ACE016.e on the agenda.

a) To consider a proposal for the vacant plots at Whitemans Green Allotment Site and agree next steps

The report prepared by the Operations Officer was noted. The Chairman applauded the resident's initiative in preparing the proposal. Committee members agreed the Parish Council would work together with the group of allotment tenants to review the vacant plots at Whitemans Green with a view to developing the area. Councillors agreed to visit the allotment site on 17/18 October to view the area first hand. It was further agreed to refer this item to the next Full Council meeting to be held on 5 November 2020.

b) To review the recommendations in the Horsefield Green Maintenance Plan and agree next steps

Council agreed to proceed with Timetable A in the above recommendations and to circulate the proposed letter/plan (printed double sided) to residents of Horsefield Green and Ardingly Road for comments.

c) To note feedback from residents on the War Memorial inscriptions
It was noted residents were unhappy about the faded inscriptions. Due to
budget constraints CPC were unable to address this issue until next year.

- d) To receive an update on the refurbishment of the churchyard paths

 Excluding one small snagging item due to be carried out on 15 October the
 entire project would be completed on 16 October 2020. Council agreed to pay
 the contractor's invoice less the retention amount of 5%.
- e) To receive a report on the churchyard tombs and agree next steps It was agreed to seek advice from Gallagher and review this item at the next meeting to be held on 26 November 2020.
- f) To consider options for expansion of the cemetery
 Gallagher advised the cemetery had existing space for 3-4 years. It was
 agreed to review this item again at the next meeting on 26 November 2020.
- g) To ratify the updated Allotment Rules and Guidelines
 Clause 21.2.b was ratified. The Assistant Clerk was requested to review the
 Rules and Guidelines to ensure the clause regarding condition of plot at the end
 of tenancy is clear in respect of withholding or refunding the deposit.

ACE017 Community

- a) To consider a resident's request to replace their boundary hedge, which borders Holy Trinity Church, and agree on the species to be planted Council agreed to the planting of Prunus Lucitanica.
- b) To note feedback from tenants on the lack of parking at allotment sites Noted.
- c) To note feedback from residents regarding pavement parking in Church Platt Noted.
- d) To consider forming a working party to promote and co-ordinate COVIDsafe alternatives for celebrating Christmas 2020 within the community, for example Christmas Lights, Scarecrows and Christmas Shop Windows competitions

Councillor Laing agreed to form a working party with Councillors Sheldon and Podmore and to prepare content for the newsletter which will appear in Cuckfield Life.
