Roads and Traffic Committee Minutes of a meeting held at 8.15pm on 22nd April 2021

RT023 To approve the minutes of the meeting held on 13th August 2020

All actions were completed.

RT025 To review a summary of data obtained from the Speed Indicator Device (SID)
Data captured by both Speed Watch and the Speed Indicator Device over the past year was reviewed. Interestingly the middle of the day was when most speeding occurred, and highest speeds were witnessed from 7pm onwards. The data analysed was attached to these minutes for information. The Clerk was instructed to contact Ansty & Staplefield Parish Council to request their SID data to incorporate into our analysis. Cllr Ceccherini would prepare a schedule for positioning the SID devices to obtain more useful data for analysis and share with the Clerk.

The Clerk was instructed to establish whether the SID devices could be used with the speed/face displays turned off to track speeds being driven without drivers being alerted.

RT026 To consider instructing a traffic consultant to undertake an analysis of potential traffic calming measures for consideration within the village
Committee resolved to instruct the Clerk to arrange a meeting with the traffic consultant at the end of May to discuss current traffic issues within the village, with a view to instructing further analysis should it be deemed worthwhile (up to the earmarked budget of £3,000).

RT027 To note items arising after the preparation of this agenda which the Chairman agrees to take as urgent. Such matters will be for noting only or deferral to a future meeting only.
Cllr Dickie referred to the recent accidents experienced within the village, which would be added to the accident log and shared with the traffic consultant for information.
