- iii. To receive an update on the Cuckfield Summer Show taking place on 4th and 5th July 2025

Rehearsal for the Cuckfield Summer Show was due to take place on the 29th June and the event was being continuously promoted.

The organisation of the Big Summer Picnic was well in hand and a meeting with the Rugby Club had taken place earlier in the week to go over the final details. A site plan and risk assessment had been prepared and was due to be communicated to all parties involved for approval. The event was being continuously promoted.

ACE007 Environment

i. To receive an update on the Biodiversity Action Plan for 2025-2030 and the Volunteer work parties on Parish Council sites

Committee noted that the BAP was well underway, and numerous activities were happening around the village.

A Butterfly transect centred on Horsefield Green had been set up with butterflies recorded by volunteers on a weekly basis till September. Two audiomoth devices to records bats were also due to be installed at Horsefield Green.

ii. To receive an update on Cuckfield Swifts evening monitoring walk that took place on 12th June 2025

Fifteen people attended the Swift Walk noting occupation of 6 boxes mainly around Brainsmead.

iii. To receive an update on the Cuckfield Bat watch that took place on 19th June

This event was well attended and was a success. Thirty people came on the bat walk and recorded two species.

The next event planned was a talk on Hedgehogs by Emily Thrift taking place at the Queen's Hall in the Council Chamber at 2.30pm on 12th July 2025.

iv. To consider the purchase of Weevils for Horsefield Green Pond at the cost of £100 to help clear the pond of the non-native water fern (Azolla) which stops light getting to the bottom of the pond

Committee agreed to the purchase of the Weevils.
