ACE013 Assets

i. To receive an update on the Cemetery

Committee noted that the cemetery was looking good. The Chapel inspection had been carried out earlier this month and Cllr Symonds confirmed it was in a very good state and well kept.

ii. To receive an update on the allotments

The inspection of both allotments' sites had been completed this month. All plots were well tended to in general and a couple of plots had become available following the inspection. The available plot at Whitemans Green was advertised on social media and three enquiries were received. This plot had now been allocated and the waiting list had been updated. Another plot had become available at the Courtmead Road site and offered to the next person on the waiting list.

iii. To receive an update on the donation of a bench for the Queen's Hall garden in commemoration of the Haywards Heath & District Canine Society celebrating 65 years this year.

Committee noted that the bench donated by Haywards Heath & District Canine Society was to be installed in the Queen's Hall garden in two to three weeks.

iv. To note AFNG is now open to the public for the summer period during the opening hours of the Cuckfield Parish Council Office, Monday to Friday 10:00 to 15:00

The committee noted there was a steady flow of visitors to the AFNG.

v. To consider when the AFNG closes for the winter months and when to hold the official opening.

Committee agreed to leave the garden open as long as possible. Committee agreed to hold the opening of the AFNG on 28th September 2025 from 3pm for refreshments in the garden. It was agreed that the Clerk would invite the guests to attend.

vi. To receive an update on the conversion of the phone box located outside the talbot into a book exchange

The Committee noted that a draft contract had been sent to the owner of the telephone box to share with their solicitors.

vii. To receive an update on the tree at the Village Hall

The committee noted that the tree surgeons recommended by Cllr Symonds had been contacted and quotes were to be received. Cllr Symonds confirmed that the crown needed to be lifted and committee agreed that this tree was to be included in the annual tree survey.

viii. To receive an update on the land at the observer field Updates were to be shared in a separate meeting.

ix. To discuss the management of the observer field going forward Cllr Podmore confirmed that he would contact the farmer to agree on a

Cllr Podmore confirmed that he would contact the farmer to agree on a suitable time for flailing the field and to discuss his proposals for installing a new stock fence, with a view to returning his sheep to graze once it was safe to do so.

Cllr Podmore agreed to prepare a management plan to be incorporated into the Biodiversity Action Plan, which would include the maintenance of the field's borders/boundaries.

Committee noted that the Big Summer Picnic was a success despite the weather. It was decided that another Big Summer Picnic will be planned for mid-June to mid-July the following year and a date was to be booked in with the Rugby Club as soon as possible.

v. To receive an update on the success of the Rain or Shine production, The Rivals, that took place in the nature garden at the Queen Hall on Friday 1st August 2025

Committee noted that the Rain or Shine production was a success with over 100 attendees.
