### Minutes of the meeting held at 8pm on Thursday 12<sup>th</sup> March 2026

**RT041 To receive apologies for absence**

**RT042 To receive declarations of interest from Members in respect of any matter on the agenda (*The disclosure must include the nature of the interest. **RT043 To approve the minutes of the meeting held on 11<sup>th</sup> December 2025**  
The minutes of the meeting held on 11<sup>th</sup> December 2025 were approved and signed.

**RT044 To note the Actions List**  
All actions were noted.

**RT045 To receive an update regarding the proposed 20mph zone within Cuckfield along London Lane/Broad Street/High & South Street**  
No further updates were available at this time. Committee noted that despite overwhelming public support, no further support had been received from WSCC.

**RT046 To receive an update regarding the implementation of a 30mph zone from the roundabout at Tylers Green through to the Bolnore roundabout**  
Committee noted that the TRO for the 30mph zone had been approved with implementation scheduled to commence from July 2026 onwards.

**RT047 To receive an update on the traffic projects for the Glebe Road roundabout, railings on London Lane and the yellow hatched box by the old chemist**  
Cllr White was due to meet with a traffic engineer on 1<sup>st</sup> April 2026 to discuss the proposed Glebe Road roundabout. Committee agreed to install reflective chevrons at the Chatfield Road corner with London Lane to improve night-time visibility and to install road warning signage on the railings as detailed in RT054.

Cuckfield Parish Council adopted the General Power of Competence on 1<sup>st</sup> May 2025, all decisions made during this meeting are done so under this power.

**RT048 To note the updates from the last Traffic Steering Group meeting and consider the proposed actions**

Committee noted the updates from the Steering Group meeting, as previously circulated.

**RT049 To note the speed watch results**

Committee noted the speed watch results.

**RT050 To note/discuss any accidents added onto the spreadsheet (circulated)**

Committee noted the accidents spreadsheet report.

**RT051 To receive an update on the potential installation of white gateways to be positioned coming into the village from Ansty**

Further update and approval were yet to be received from WSCC Highways.

**RT052 To receive an update on the verge parking issues on Tylers Green Road**

Cllr White had been in contact with the residents reporting the issue and had suggested various measure to help deter the parking on the verges.

**RT053 To review the quotes for TrafficRadar**

Committee noted the proposed quotes and agreed not to proceed with TrafficRadar at this time. Committee resolved to purchase and install additional Speed Indicator Devices (SIDs) within the village and to review the budget towards the end of the next financial year.

**RT054 To consider buying a banner displaying a road warning sign to be positioned on the railings at the bottom of London Lane as a temporary preventative measure**

Committee agreed to purchase a banner displaying road warning signage to indicate the sharp bend in the road as a preventative measure.

**RT055 To consider the parking on Brock End**

Committee noted the parking issues on Brock End and agreed that these were related to the ongoing works at the Co-op and were expected to be resolved upon completion of the works.
